Agustín Parise receives the Cueto Rúa Award 2008

Agustín Parise, LSU LLM 2006 and Research Associate at the CCLS, is the first recipient of the Cueto Rúa Award, created this year by the Argentine Association of Comparative Law, in honor of the late Julio Cueto Rúa. Professor Cueto Rúa, a prominent scholar in Argentina and Spanish speaking countries, taught at LSU, and wrote leading texts on the common law and civil law.

Agustín Parise received this prestigious award for his paper on *The importance of comparative law scholars and law libraries for the understanding of the law*, focusing on Gustavus Schmidt, a 19th

century scholar who created the first law journal in Louisiana. The ceremony took place at the National Academy of Law and Social Sciences of Argentina, in Buenos Aires, on December 16th. The Academy is a hall of fame for LSU: Professor Litvinoff was inducted into the Academy in summer 2007.

Civil Law Workshop, Saúl Litvinoff Series

The LSU Law Center has declared 2009 the Year of Litvinoff. The 2009 Civil Law Workshop Series is dedicated to our eminent civilian and comparativist, at the time where he moves to retirement after a rich career as practitioner, teacher, author, and reformer of the civil law of Louisiana. The general topic of the Series is ***Civil Law and Common Law: Cross Influences, Contamination and Permeability***.

International Colloquium at Tulane Law School

On November 22, Professor Olivier Moréteau made a presentation on ***Recodification in Louisiana and Latin America***, prepared with Agustín Parise. This closed a one-and-a-half day session on *Challenges of Recodification Worldwide*, the second part of the International Colloquium, presented by the Eason-Weinmann Center of Comparative Law and the Tulane Law School to celebrate the **Bicentennial of the Louisiana Civil Code**.
