The next week, he taught Introduction to the Common Law Systems classes for the Université de Nantes, to students of the Master of Trilingual Legal Studies on the La Roche-sur-Yon campus. On December 6, at La Roche-sur-Yon, he presented a paper on same-sex marriage and union in the United States, at a conference addressing "(il)legally recognized unions, international approaches." Conference papers (including presentations related to China, France, Italy, and Spain) are to be published in Volume 7 of the Journal of Civil Law Studies.
