### *French Interns, Students, and Scholars visiting at the CCLS*

## **Professor Emeritus Robert A. Pascal Turned 100**

Professor Emeritus Robert Anthony Pascal celebrated his 100th birthday on July 5, 2015. A long time LSU law professor, he taught the civil law and international private law in Baton Rouge, and also in Rome and in Paris. His scholarship spanned over 72 years, with a first article in the very first issue of the Louisiana Law Review in 1938 and an electronic book in 2010: see [Robert Anthony Pascal, A Priest of Right Order](#) (O. Moréteau ed.), including a selection of his best articles and a so-far unpublished memoir (Recollection of a Life Studying and Teaching Law).
