### *Lectures*

On May 29, **Prof. Olivier Moréteau**, Russell Long Chair, gave a lecture at the Austral University (Buenos Aires, Argentina), on *Drafting Contracts and Juridical Documents in Several Languages*.

### *Induction to the Academy*

On May 24, **Prof. Saúl Litvinoff** (Boyd Professor, Louisiana State University) was inducted to the Argentine National Academy of Legal Science. He gave a lecture on *Otra Mirada al derecho angloamericano*. Prof. Litvinoff also lectured at the Austral University and the University of Buenos Aires.

### *Summer Programs*

From May 14 to June 2, the LSU Paul M. Hebert Law Center offered its first Summer Program in Argentina, in cooperation with Austral University in **Buenos Aires**. Seven LSU students were able to share a unique academic experience with nine Argentine students. Courses were taught by Prof. Julio Kelly (Di Tella), Santiago Legarre (UCA), Olivier Moréteau and Alberto Zuppi (LSU). Visits to the Argentine Supreme Court, Congress, and the Central Bank were held during the Program.
