Translation Projects: A Team of Francophone Jurilinguists at Work

As in 2011, the CCLS is hosting a team of scholars from the Université de Nantes (France) from April – June. **Anne Perocheau** and **Anne-Sophie Roinsard** are students in the Master's in Trilingual Legal Studies (*Master Juriste Trilingue*). Under the coordination of CCLS Director Dr. Olivier Moréteau, the team is working on the following projects:

- Translation from English into French of the current Louisiana Civil Code;
- Translation from French into English of some civil law terms of the *Vocabulaire juridique Cornu*, a project sponsored by the *Association Henri Capitant des amis de la culture juridique Française*, and supervised locally by Prof. Alain A. Levasseur, President of the Louisiana Chapter.

The team meets twice a week, to discuss the translations prepared by Anne and Anne-Sophie, who also do the research work. Prof. Anne Tercinet (EM Lyon, presently visiting at LSU Law) and Daniel On (LL.M. Candidate and Research Assistant for Prof. Moréteau) also attend and contribute at meetings.
