**Professor Olivier Moréteau**, Russell Long Chair, presented a paper on “The Frontiers of Law and Language” at an international conference hosted by the Italian National Academy “dei Lincei” in Rome, on March 12<sup>th</sup> and 13<sup>th</sup>, 2008. The general theme was “The New Ambitions of Legal Science: Legal Anthropology and Legal Traductology.”

On March 28<sup>th</sup>, **Professor Olivier Moréteau** presented the French Report at the 7<sup>th</sup> Annual Conference on European Tort Law, organized in Vienna by the European Centre of Tort and Insurance Law and the Research Unit for European Tort Law of the Austrian Academy of Sciences.
