Journal of Civil Law Studies: Moving On

➤ **A Peer-Reviewed and Student-Edited Journal**

In 2008, the Center of Civil Law Studies of the Louisiana State University Paul M. Hebert Law Center (CCLS) started publishing the *Journal of Civil Law Studies* (JCLS). Volume 1 of the JCLS appeared in 2008. Two volumes have been added in 2009 and 2010.

The JCLS is peer-reviewed. The Advisory Board is composed of distinguished civilians and comparatists from all over the world. **Olivier Moréteau** serves as Editor-in-Chief, assisted by **Agustín Parise** (presently a Research Fellow at the Max Planck Institute in Germany), Executive Editor. Two Book Review Editors recently joined the team: **Philipp Gragg** (Interim Associate Director for Public Services, and Reference and Faculty Services Librarian, LSU Law Center) and **Heather E. Casey** (Reference and Research Services Librarian, University of Richmond School of Law). **Jennifer Lane** serves as the Production Manager.

Accepted publications are edited by student editors (Junior and Senior Graduate Editors). Their editorial work is reviewed and finalized by **Andrew Yeates**, Managing Editor, who also coordinates the team. **Micah Fincher**, who serves as the Issue Editor, conducts the final formatting of each article and the entire issue.

➤ **Moving to Three Issues a Year**

Starting in 2011, each volume will be divided into several issues. Volume 4 (2011), Issue 1 (due in April) will feature six articles including “Is the pre-20th century American legal system a common law system?” by Jacques Vanderlinden and “Juridical Personality and Intimacy” by Michael McAuley.

Issue 2 will feature papers presented at the *Juris Diversitas* conference on “Legal Diversity in the Mediterranean,” organized in Malta in June 2010, in cooperation with the University of Malta.

Issue 3 will feature a selection of articles including “A Comparative Survey on Finance: the Need to Bridge the Western and Islamic Legal Systems” by Andrea Borroni and Matteo Dragoni. It will inaugurate a new **Student Section** publishing Essays or Comments by LSU J.D./D.C.L. and LL.M. Students.

➤ **Future Developments**

Volume 5 (2012) will inaugurate two additional sections:

- **Civil Law in Louisiana**, featuring recent developments in the civil law of Louisiana;
- **Civil Law in the World**, focusing on recent developments in civil law jurisdictions around the world.

With three issues a year and a significant student involvement, the JCLS is becoming an important component of the LSU Law Center experience. The LSU Law Center is now running two law reviews.
